Celebrate the present Cooperation Protocol for the joint execution of the operation “**Loureiro: produção e promoção**”, under the Operation 10.31 “LAGs Inter-territorial and Transnational Cooperation” of RDP2020 area number 4 “Local Development”, on the following terms:

ART. 1

Object

The present Protocol defines the aims and objectives of the Partnership and the obligations, responsibilities and specific contribution of each intervening entity, whose content was approved by all signing Parts.

ART 2

Aims and Objectives

The Partnership established by this Cooperation Protocol has as objectives:

- a) Cooperate to share experiences on strategies for the stimulation of territorial promotion, through wine production and its associated economic actors;
- b) Compile, systematize and publish information on the production and promotion of excellency wines in each territory, with a focus on their history and traditions, on their characteristics and on good practices for production and promotion.

ART 3

Designation of the Cooperation Project Coordinator

The Partners, in agreement, designate **GAL ADRIL** as Cooperation Project Coordinator, responsible for the Partnership’s administrative and executive management.

ART 4

Duties of the Cooperation Project Coordinator

The Cooperation Project Coordinator is due to:

- a) Represent the Partnership;
- b) Coordinate the Cooperation's activities;
- c) Answer, as spokesman in representation of all partners, to the information requests presented by the RDP 2020' MA;
- d) Inform the Partners about the results of the PDR 2020' AG adopted resolutions;
- e) Afford a specific and dutifully organized Cooperation dossier;
- f) Deliver information for the legally provided national data base;

ART 5

Duties of the Partners

1. All Partners shall follow the stipulated obligations of Art 24 from Decree-Law nº 159/2014, 27 October, as well as Art. 10 from the Application Regulation of the Operation 10.3.1. "LAG Inter-territorial and Transnational Cooperation".
2. All Partners shall answer and collaborate with the Cooperation Project Coordinator under the stipulated competences of the Partnership.

ART 6

Operation Investment

The Parties undertake the total investment under the terms approved by the RDP 2020 Management Authority, as follows:

Conflict Management in the Partnership

1. The Partnership, composed by the Parties in this Cooperation Protocol, is responsible for addressing all the quarrels that may arise. However, should the Partnership be unable to solve the disputes and should those feuds impend the proper execution of the Operation, risking the fulfilment of the proposed objectives, the Operation can be revaluated and the terms of the present Protocol may be changed, upon approval of the RDP 2020 Management Authority, under Art. nº 3 and following.
2. Without prejudice to the provisions of the preceding paragraph, the non-compliance with the objectives of this Partnership may, after evaluation of the circumstances, constitute ground for termination of the present Protocol and of the Financing Contract celebrated with IFAP.

ART 9

Application of the Protocol

1. The application of the Protocol is conditioned, by all means, to the approval of the Application for Financial Support under the RDP 2020.
2. The present Protocol applies for the duration of the Operation.
3. Any change to the present Protocol during the execution of the Operation shall be approved by the Partnership and previously submitted in written form to the LAG.
